Meeting Called to order at 7:00 pm by Judy Miracle. Pledge of Allegiance—All participated

Approval of Agenda— As amended Ken motioned & Ron seconded--motion carried.

Approval of Minutes—As amended Ron motioned & Mary seconded—motion carried.

Treasurer's Report—As presented June motioned & Ken seconded—motion carried.

Blacksmith Shop—Blacksmith Committee (Ron, Mary Alice, Arnie and Mary) made progress report. Plans have been presented to Fire Department, and Building Department in the Village to see if there are questions that could be answered/problems solved before the final package is to be presented to the Village. All concerns were addressed and the approval of the Blacksmith Shop is on the agenda on Monday 5/20/2019 and the Councilman's package will be presented. Mary Alice is looking into a \$4000.00 grant, information to follow. The budgetary figure is \$20,000.00. There has already been \$7,500.00 (budgetary figure) of in kind services that have been promised. Ron is also looking into the possibility that the Village will not charge for permitting fees. Permits will be pulled but the fees will be waived. Lee Palasam has already provided \$1000.00 in kind services getting architectural plans created to give to the Village. The other companies are Grislley Electric and Mann Equipment, have said they would provide services. Discussion on where the \$13,000.00 for a sinking fund for the Blacksmith Shop will come from was put forward as the Reserve Fund (CD) and the Edward Jones account would be closed out. The Reserve Fund was for a Blacksmith Shop (years ago) and Gwen Hamilton-Wyatt, (who donated the Edward Jones account) said she would like the money to be used for a big project, not day to day expenditures. The balance to get the sinking fund to the \$13,000.00 balance would come out of the Oxford Bank checking account. An article in the Citizen Newspaper would also let the community know about the Blacksmith Shop and ask for donations to go toward the shop, thus less money would be taken out of the checking account. It was pointed out that these figures are budgetary and could run higher. Ken seconded this motion—14 for approval and 0 against—motion passed.
